1.4 Māori and Pasifika Presentation

Afamasaga Uli Pesefea and Hone Rask - Māori and Pasifika Department gave a verbal presentation to the Board.

Key highlights:

- The implementation of the Cultural Studies class at kura this year. There are two classes, one is Year 11 and 12's with around 40 students, 5 of which are international students and then a separate Year 13 class with 24 students. Currently the subjects covered are Dance and Te Ao Haka and the vast amount of knowledge and experiences that comes with that.
- Providing kaupapa for the junior students, this year the Year 9 Māori and Pasifika students
 participated in Te Waka Voyaging. One session was around knowing your identify and
 your whakapapa and the importance of connecting with one another.
- The Homework Club, this is a programme run after school on Mondays, it has been running since the start of Term 2.
- Manu K\u00f6rero success 2023, came third overall, only beaten by full M\u00e4ori immersion schools.
- Kapa Haka success, performing as a boys only school.
- Implementation of a third whānau form class for 2024.

Further discussion took place regarding the goals going forward, this included Cultural Studies being taught at junior levels, student engagement, connection and student success and staffing. Afamasaga Uli and Hone left the meeting at 6.51pm.

The Tumuaki advised the Board of the ongoing contact with ShapEd regarding the school playing fields, along with a group of students that have got a petition going and collected student voice as part of an assignment and have written to ShapEd about the state of the playing fields, (reply taken as read), along with a letter from the Director of Spartan Sport who has raised concerns about the fields around the fact they are very rarely used and are in terrible condition. Also raised as a concern from the Whānau Committee this evening.

The fields continue to be extremely wet and were closed for the first five weeks of Term 3. This is now undermining the mana of the school and we cannot deliver a PE curriculum on the fields which is not acceptable as it is compromising teaching and learning.

Feedback will be presented at the next property meeting in three weeks, this is following the New Zealand Sports Institute coming in to carry out a report on the state of the fields.
